Sir,

The status of the research project titled "Preparation & Maintenance of Bear Studbook" has been examined before the Technical Committee of the Central Zoo Authority in its 83<sup>rd</sup> Meeting held on 19.05.2017. The committee decided to consider the project as closed since the Wildlife SOS has surrendered the grant of Rs. 3,52,000/- which was released as first instalment vide letter dated 31.03.2011.

Further, the committee decided to recover penal interest at the rate of 10% per annum as per provision under Rule No. 258(1) of GFR, 2017 from the Wildlife SOS. The decision was taken in your presence, being a member of Technical Committee of Central Zoo Authority wherein you agreed to pay the same.
