Sub: Proposed designs for the construction of various enclosures at Lucknow Zoological Garden, Lucknow.

Sir,

The proposed designs for the construction of various enclosures at Lucknow Zoological Garden, Lucknow were placed before the members of the Expert Group on Zoo Designing of the Central Zoo Authority in its Meeting held on 5th June, 2014. The proposal was scrutinized and following observations were made:-

a. Renovation of Bird aviary

As the proposal is relates to renovation of the aviary as such the approval of the Central Zoo Authority is not required; however the works may be carried out looking at the aesthetics, biological need etc. In no case structure should dominate the animal exhibit i.e. it has to be naturalistic.

b. Enclosure for Wolf

The design was scrutinized and approved subject to the following rectifications:-

- i. Grouting of fencing post should be 900 mm below the ground level.
- ii. Wolf enclosure should be located away from primate enclosure.
- iii. The cats can come nearer to the primate enclosure.

c. Enclosure for Leopard

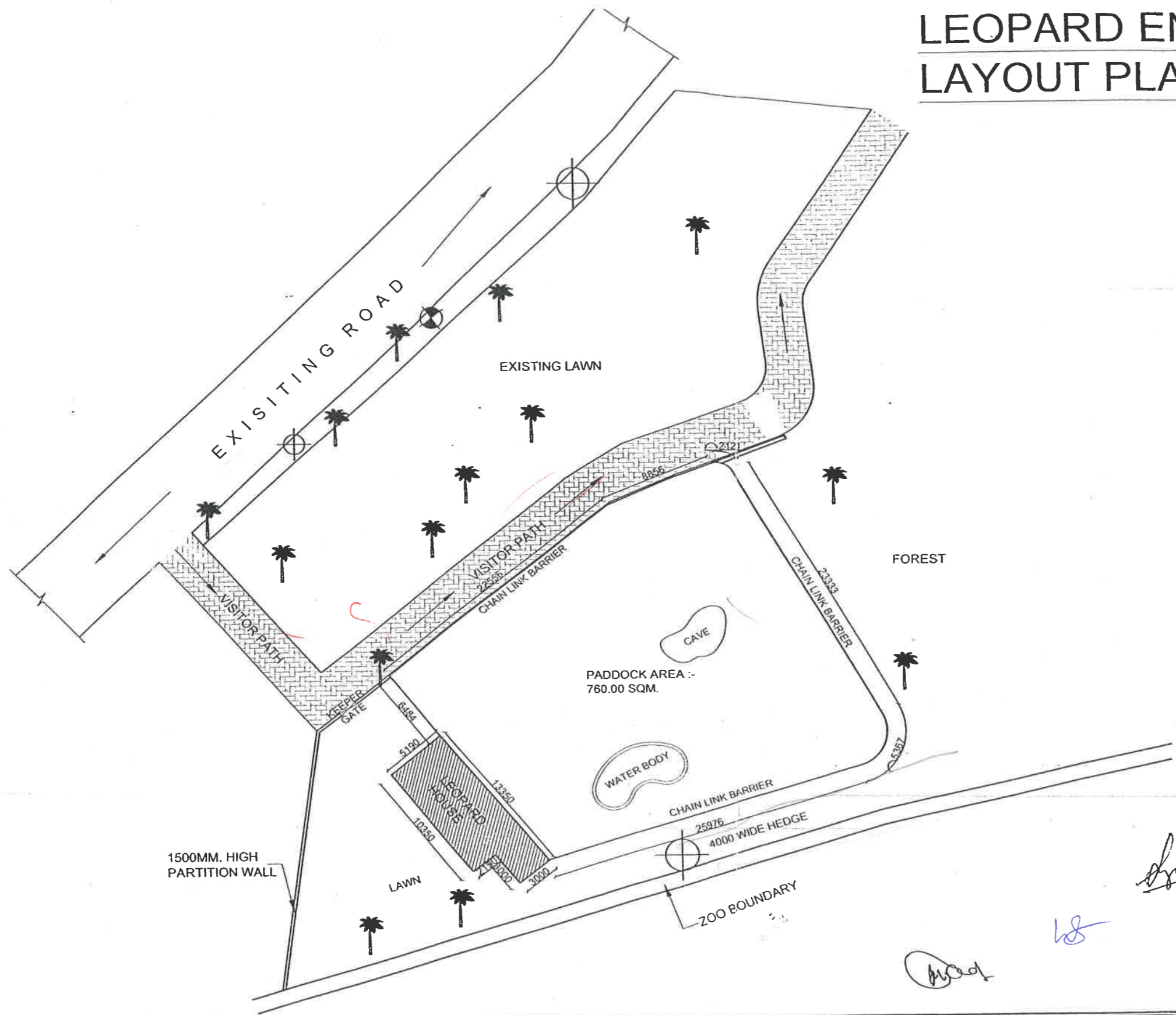
The design was scrutinized and approved subject to the condition that the height of the chain-link fencing should be increased to 5mts. from 4 mts.

LEOPARD ENCLOSURE LAYOUT PLAN



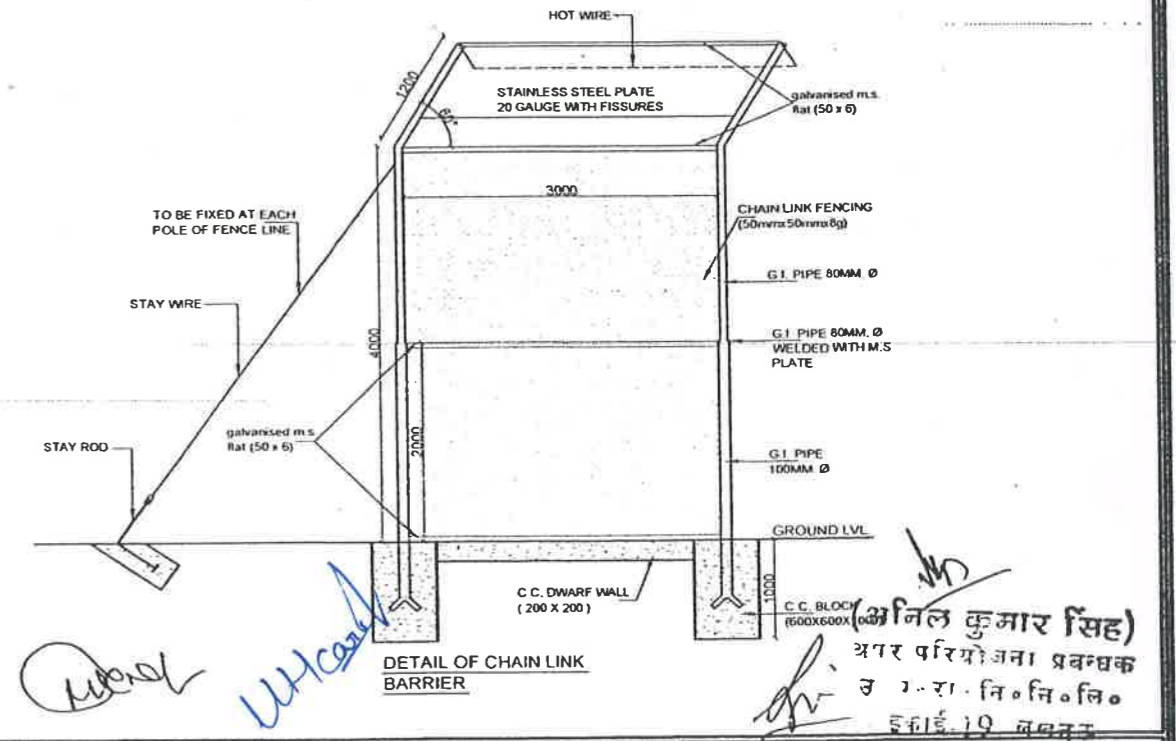
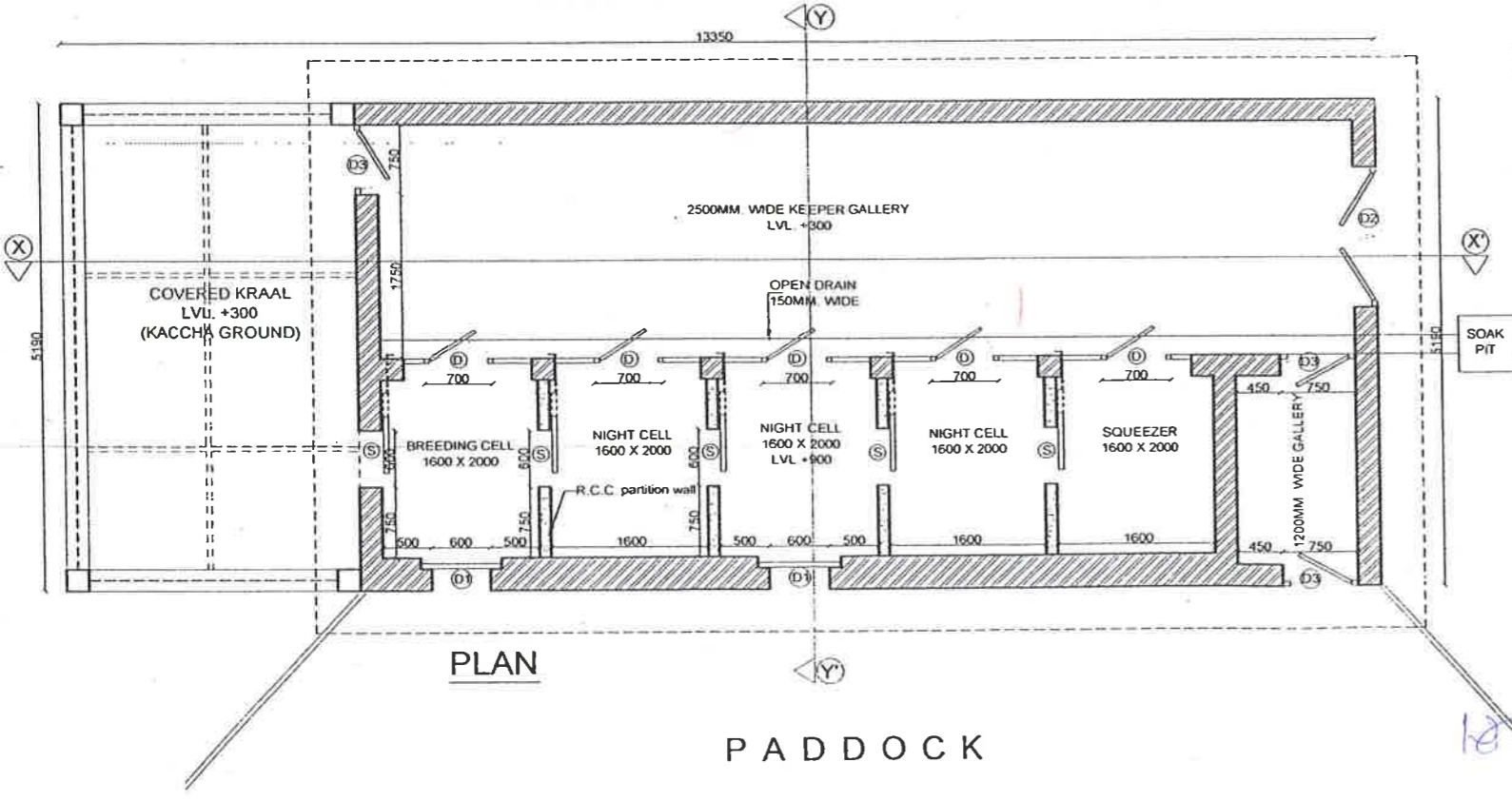
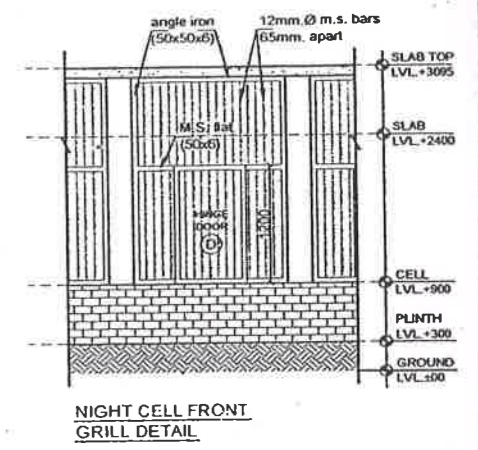
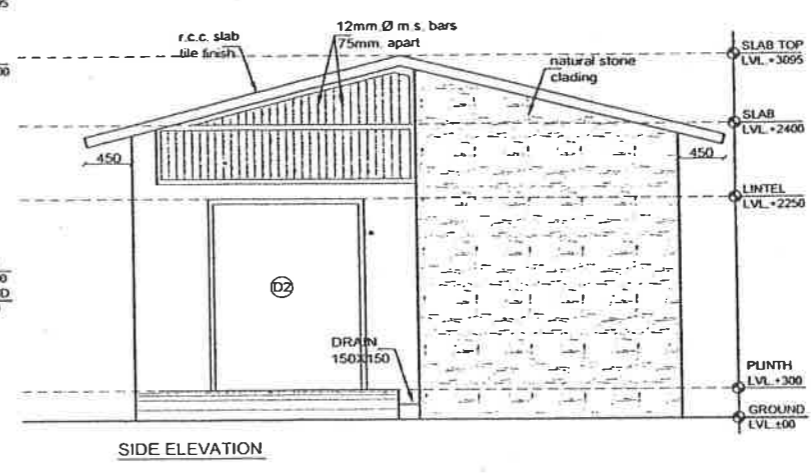
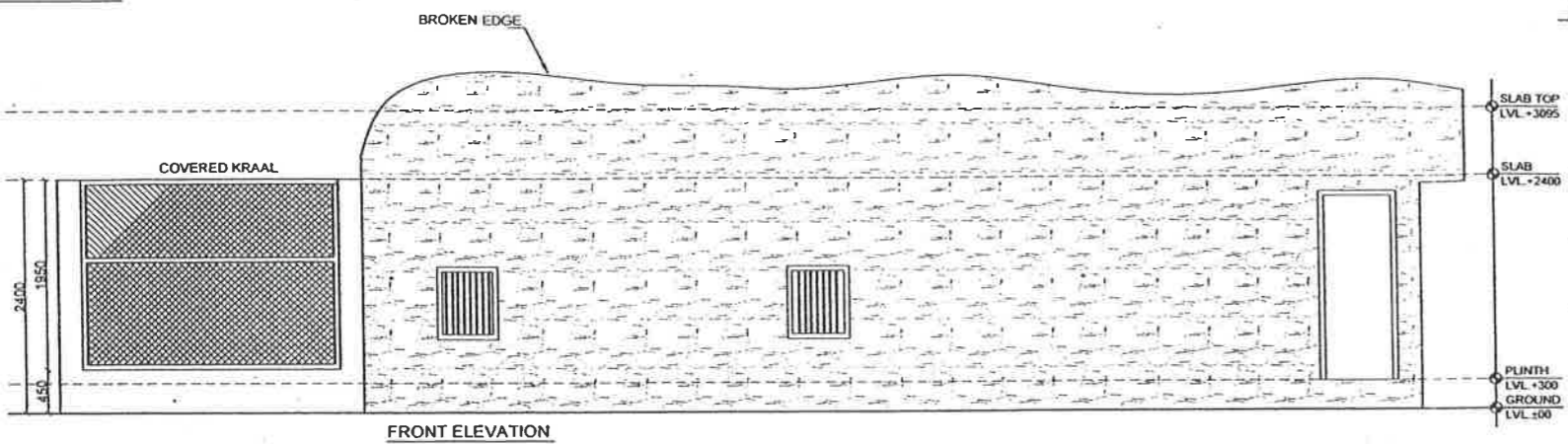
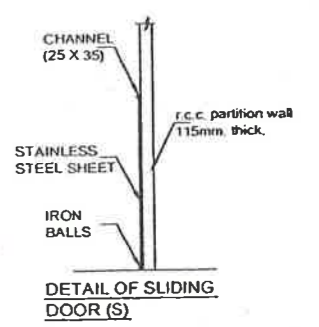
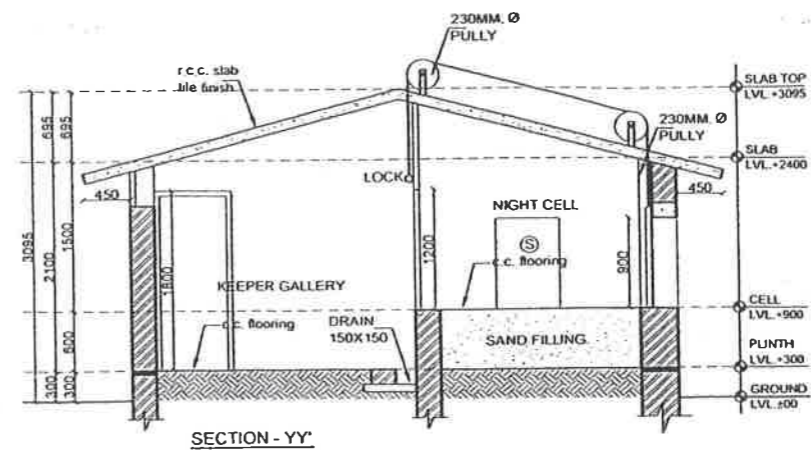
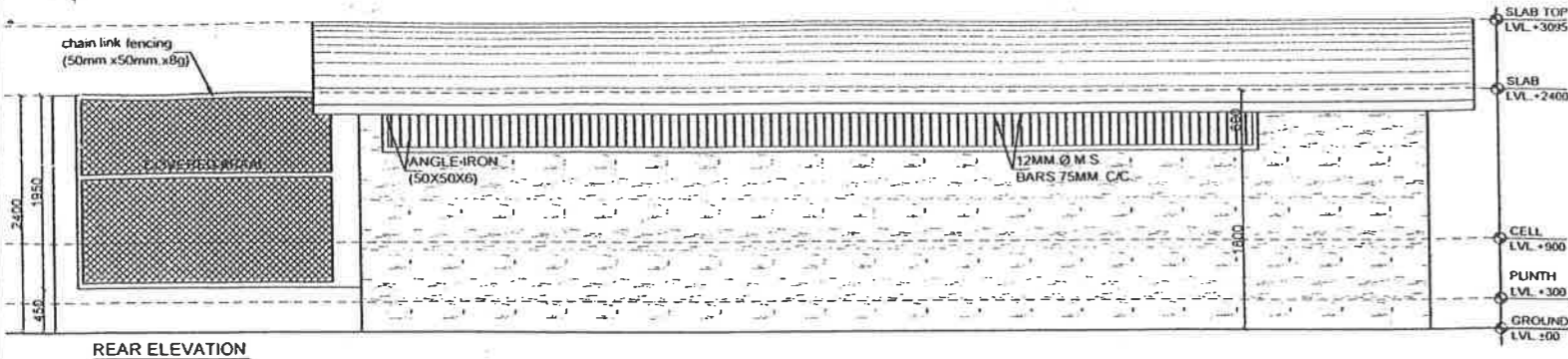
