The Chairperson of the Authority is the Minister, in charge of the Environment, Forest and Climate Change, Government of India.

2 . Subsequently, in exercise of powers conferred by Section 38D(2) of the Wild Life (Protection) Act, 1972 (Act no. 53 of 1972), and in supersession of the office order F.No.7-2/2020-CZA(D)/2514/2020 dated 15/7/2020, except in respect of things done or committed to be done before such supersession, and with the approval of the Chairperson of the Authority, a sub-group named Expert Group on Zoo Designing is hereby reconstituted with the following composition –

- 3. The terms of reference for the Expert Group on Zoo Designing are as follows -
- a) To scrutinize, suggest improvements/alterations in proposed Master Plan (including layout plans) aimed at the long-term development of recognized zoos and provide recommendations to the Technical Committee for further deliberation.
- b) To scrutinise and approve/disapprove designs for animal enclosures in line with the provisions outlined in the Recognition of Zoo Rules, 2009. Additionally, the committee offers suggestions for improvements or modifications where applicable, ensuring compliance with extant statutory provisions.
- c) To formulate standards and norms governing the design of animal enclosures for various species housed within recognized zoos aimed at ensuring optimal housing conditions, welfare, and safety for the diverse range of animals in zoos. The recommendations are provided to the Technical Committee for further deliberation.
- 4. The term of the Expert Group on Zoo Designing will be coterminous with the Central Zoo Authority constituted for a period of three years vide notification S.O. 4057(E) published in the Gazette on 13th September, 2023.
- 5. The non-official members shall be eligible for sitting fees as per extant provisions of the Government of India.

6. The members shall be eligible for payments of T.A/D.A for attending the meetings as per extant provisions of the Government of India.

This has the approval of the Chairperson, Central Zoo Authority and Minister for Environment, Forest and Climate Change, Government of India, New Delhi.
