If so, please inform me name of officers of PCCF (Wildlife), U.P. who were deputed on 1 st Feb, 2015 and 8 th Feb, 2015 at Police Line Ground, Lucknow to have a vigil on the proceedings of dog shows organized by Amar Ujala Group and by Oudh Kennel Club, Lucknow.	The reply to said query does not comes under the purview of Central Zoo Authority.
2.	Please inform me whether any instruction was given to PCCF (Wildlife), U.P. by CZA to submit any official report on the proceedings of these dog shows. If so, please provide me a copy of such report.	The Central Zoo Authority vide its letter no. 22-81/2004-CZA (498)(Vol. I)(AK), dated 14.01.2015 had asked the PCCF (Wildlife), Govt. of Uttar Pradesh to submit the factual status report on the matter.
3.	Please inform me whether any instruction was given to PCCF (Wildlife), U.P. by CZA to report the number of exhibit dogs whose vaccination certificates were found proper and complete and the number of dogs whose vaccination certificates were fake and forged.	The report is yet to be received from the PCCF (Wildlife), Uttar Pradesh.
4.	Please inform me whether any instruction was given to PCCF (Wildlife), U.P. by CZA to take necessary action against the organizers of dog show for submitting fake and forged vaccination certificates.

6.	Kindly inform me which special precautions were undertaken by PCCF (Wildlife), U.P. to safeguard endangered Asiatic lions and tigers housed in Lucknow Zoo (which is situated just at 1 Km. air distance from dog show ground) against spread of highly fatal
