

Udyan Zoo, Byculla, Mumbai.  For your information, this Authority does not operate or maintain any zoo in the country. The said zoo i.e., V.J.B Udyan Zoo, Byculla is operated and maintained by the Municipal Corporation of Greater Mumbai therefore may seek information directly from the concerned authority.
2.	Annual budget allocation for the Rani Baug Zoo for 6 years listed below with details for specific activities and expenditure for these activities.	
3.	Budget for the redevelopment of the zoo with specific allocation for different activities/functions/portfolios.	
4.	Database of the detailed observations about the biological behavior, population dynamics and veterinary care of the animals exhibited at the zoo.	
5.	Veterinary reports for all animals deaths that have occurred in the zoo over the given period of time.
