In response, the competent authority has made certain observations. They are as follows: 1. The rates prior to 01.10.2015 (dates of revision) shall be applicable for the case, except for a hearing due in November as stated by the advocate, since the case is old one. 2. The rates for CSC shall be applicable, if otherwise, please putup relevant records. 3. The concerned section handling the case to certify that the three affidavits have been drafted. It be verified from the file. 4. Two conference fee be verified, when was it made and who made it. 5. The hearing on 19.11.2015 be verified and its outcome has not been placed in the file. It be verified from the website of the court. 6. The bill be examined once again thoroughly by the finance in consultation with concerned section. |
