3.	Please mention in detail along with dates- the chronological actions taken by the CZA till now upon the recommendations of the Selection Committee made in the meeting held on 1.9.2017.	The matter is still under consideration and no final decision has taken so far.
4.	Whether the recommendations of the Selection Committee made in the meeting held on 1.9.2017 have been approved by any authority of MoEFCC such as (i) Special Secretary & DG Forests (ii) Secretary (iii) Minister. If yes, please provide the name(s) of authority(ies) which approved the recommendations along with date(s) of approval. If not, please provide the reasons for non-approval. Please also inform about the clarification received from the DoPT in the matter including the date and letter number and the name of post which is considered analogous to the aforesaid post of DIG according to the DoPT. Copies of all letters relating to correspondence with DoPT in this matter should also be provided.	The matter was forwarded to the Wildlife Division of MoEF&CC for onwards consideration and orders. For remaining information, your RTI application is being transferred to the PIO, Wildlife Division, MoEF&CC under Rule 6(3) of the RTI Act, since it has been dealt by them.
