Sir,

I am referred to National Tiger Conservation Authority letter No.10-1/2018-NTCA dated 17.07.2018 received by this office, wherein the reply of your appeal has been forwarded to this office for information and necessary action.

In this regard, with reference to your RTI application dated 27.03.2018, the replies to your queries are as follows:

1. Conducting investigation or any laboratory tests for diagnose presence of CDV (Canine Distemper Virus) or others on captive animals housed by zoos is sole duty of operator of the Zoo. In this connection, the Nawab Wajid Ali Shah Zoological Garden, Lucknow comes under the control of Chief Wildlife Warden, Uttar Pradesh. You are, therefore, requested to obtain the desired information directly from CWLW, Uttar Pradesh.
2. The order issued by NTCA to Chief Wildlife Warden of all States to examine wild population of tigers, it does not apply on captive tigers.

In case you are not satisfied with this reply, you may file an appeal before the appellate authority, i.e. Member Secretary, Central Zoo Authority, B-1 Wing, 6th Floor, Pt. Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi – 110 003, within a period of one month.
