**Subject: Financial Grant given to Hanuman Vatika, Village Sultanpur, District Gurgaon, Haryana.**

Dear Sir,

Please refer to your letter dated 6.9.2018 on the above subject. It is submitted that the financial grant of Rs. 10 lakhs was utilised over a period of four years and the final amount was utilised during the year 2016-17. Accordingly, the utilisation certificate for the same was given only after the entire amount was utilised. The said grant has been utilised for the infrastructure and operative expenses towards rescue and upkeep of monkeys.

2. We sincerely feel that the demand to repay the financial grant is unjustified. However, in case the Central Zoo Authority still feels that the same should be returned, it is requested that the amount to be returned may be communicated immediately. Since People for Animals is a non-profit organisation dedicated to welfare of animals, any interest on the grant amount may please be exempted.

## Additional Agenda Item No. 1

### 1. Financial Grant Given by the Central Zoo Authority to the Hanuman Vatika Rescue Centre , Village Sulatnpur, District Gurgaon, Haryana being run by the Trustee of People for Animals, New Delhi

The Central Zoo Authority had provided Rs. 10.00 lakhs to the Hanuman Vatika Rescue Centre for development works during 2011-2012. The utilization certificate for the same was received during October, 2016.

The Central Zoo Authority vide its letter dated 02.12.2016 had cancelled the recognition of Hanuma Vatika Rescue under Section 38 H (6) of the Wildlife (Protection) Act, 1972 since the Rescue Centre operator vide letter dated 27.09.2016 had informed this office that all captive animal have been removed from the Hanuman Vatika Rescue Centre rehabilitated and that now wild animal will be housed at the facility thus the recognition to the facility was cancelled.

During 2018, an RTI was filed by Mr. Naresh Kadyan seeking details on the Hanuman Vatika Rescue Centre and fund released them and raising the issue that the trustee of People for Animals have not utilized the funds.

The CZA had also written to Trustee, PFA vide letter dated 06.09.2018 that to provide details with regard to utilization of funds, asset created and directing to refund the funds provide by the CZA with interest.

The Trustee, People for Animals, New Delhi vide letter dated 19.09.2018 had informed that though the entire amount was utilized, however, in case the Central Zoo Authority still feels that the same should be returned, the PFA has requested CZA to inform so the amount shall be returned. In the same letter, the Trustee, PFA has written that being a non-profit organization dedicated to welfare of animal, any interest on the grant amount may please be exempted.
