ORDER

Whereas, Shri Naresh Kadyan submitted an RTI application dated 30.09.2018. The RTI information sought is in respect of following subject matter;

1. Copies of security, surety bond submitted by Maneka Gandhi to obtained grant in aid Rs.10.00 lakh under cover Hanumanvitka from CZA
2. Status with action taken reports on the false, fabricated and bogus statements of Maneka Gandhi to misguide the Authorities of CZA that she occupied HanumanVatika last 20 years, spent over 1 Crore on it, as perjury vide her letter dated 16.03.2011
3. Copies of reply submitted by Maneka Gandhi People for Animals, keeping in view recovery Notice of the grant in aid Rs.10.00 lakh by CZA vide letter dated 06.09.2018
4. Copies of agenda placed before the Technical Committee on the said reply of Maneka Gandhi PFA against CZA notice dated 06.09.2018
5. Copies of minutes of the Technical Committee of CZA, proceedings related to Maneka Gandhi PFA reply
6. Complete details of amount recoverable from Maneka Gandhi PFA, Principal amount along with Norma and Panel interest related to Hanumanvitaka
7. Copies of legal copies of trust deed, action taken against Mankea Gandhi with her Associates, involved in embezzlement of public funds, adopting perjury, breaching trust, violating terms & conditions, cheating, criminal conspiracy etc because violations of the Indian Penal Codes be handled by the Coe of Criminal Procedure
8. Copies of trust deed with legal action taken against Rita Singh of Krishana Ashram with her Associates, involved in embezzlement of public funds, adopting perjury, breaching trust, violating terms & conditions, cheating, criminal conspiracy etc because violations of the Indian Penal Codes be handled by the Code of Criminal Procedure
9. ANIMAL FARM obtained grant in aid under Scheme of the Shelter for Animals in distress on the same piece of land from the Animal Welfare Division, copies of utilization of said grant in aid also be supplied with the valuation report of XEN PWD (B&R) about structure created
10. Animal Farm obtained grant in aid under scheme of Animal Ambulance, copies of utilization of said grant along with status of vehicle purchased with the grant in aid of the Ministry.
11. People for Animals of Gautam Grover also sanctioned and disbursed grant in aid by the Animal Welfare Division, please supply me the copies of utilization certificate with the stratus of vehicle purchased with the grant in aid and copies of trust deed.

Whereas, the PIO, Central Zoo Authority provided the relevant information as per records of the CZA to the applicant vide letter No. 13-4/2006-CZA(Vol.VII)/4498/2018 dated 05.10.2018.

Whereas, the applicant was not satisfied with the reply furnished by the PIO, CZA. Accordingly, he submitted an Appeal dated 8th October, 2018.

Whereas, the applicant was given an opportunity of hearing before the undersigned at 03:00 PM on 30th October, 2018 vide CZA letter No. 13-2/2016-CZA/4638/2018 dated 18.10.2018.

Whereas, the applicant attended the hearing at 03:00 PM on 30.10.2018 and explained his stand and submitted that he may be allowed to examine the concerned file also. The matter has been examined by this Authority and the PIO, CZA is advised to provide the copy of relevant documents to the Applicant and he be allowed to examine the concerned file.

And, Shri Kadyan is satisfied with the above decision. Hence, the Appeal of Shri Naresh Kadyan is hereby disposed off.

And, the RTI applicant is further informed that he may approach the second Appellate Authority, i.e. Central Information Commission, under the provisions of the RTI Act, 2005, in case he is not satisfied with the present order.
