3.	Kindly share the order passed by CZA de-recognizing captive animal facility of Amar Circus.	
4.	Has Amar Circus applied for fresh recognition or renewal of recognition as 'Captive animal facility' If yes, please share a copy of that application submitted by Amar circus. Also, share documents pertaining to the action taken by CZA on such application of Amar Circus.	Amar Circus has not applied to CZA for fresh recognition as 'Captive animal facility'. Thus the providing the copy of application does not arise.
5.	Kindly provide documents containing details of all wild animals protected under Wild Life (P) Act, 1972 and exotic species animals and birds presently in custody of Amar Circus. Kindly provide details of the number and species of such animals and birds in custody of Amar Circus.	Since, the grant of recognition to Amar Circus was cancelled by CZA on 09.01.2014, the CZA do not have list of present exotic species of animals & birds housed by the Amar Circus.
