It is to inform that Central Zoo Authority received Inventory Report from Zoos on quarterly and financial year basis. The CZA has received Inventory Report upto June 2018 from National Zoological Park, New Delhi. Copy of the desired report shall be provided on payment of charges to make photocopies of desired documents i.e. Rs.28/- (@2/- per page, for total 14 pages in favour of Central Zoo Authority either in the form of Postal Order or Demand Draft, payable at New Delhi. The RTI application is being transferred to National Zoological Park, New Delhi to provide the information for the period from July 2018 to 22 January 2019.
2.	Total number of births, acquisition and disposal in the National Zoological Park from the year January 1, 2018 to January 22, 2019 with a break up of the names of animals, their sex and species name.	
3.	Opening stock and the closing stock of animals in the time period of January 1, 2018 to January 22, 2019 at the National Zoological Park	
4.	Total number of wild animals rescued and rehabilitated by the National Zoological Park from January 1, 2018 to January 22, 2019 with a species name break up along with their sex	
5.	Total number of animals shifted to the National Zoological Park for treatment and the number of animals returned to their enclosures from the year January 1, 2018 to January 22, 2019 with a species name break up along with their sex	The desired information will be provided by National Zoological Park, New Delhi.


