Sir,

The Central Zoo Authority released a grant of Rs. 1,42,267/- towards the above mentioned project on 15.12.2010 to the Madras Crocodile Bank Trust, Mamallapuram, Tamil Nadu. The project was to be completed within 5 months. The Madras Crocodile Bank Trust, Mamallapuram, Tamil Nadu has surrendered the earlier grant released by the Central Zoo Authority amounting Rs. 1,42,267/- towards the aforesaid project, since the project could not be completed by them since the project personnel left the organization..

However, Madras Crocodile Bank Trust vide reference above, submitted a report of the aforesaid study with request that money surrendered by them be reimbursed towards the project.

On perusal of the project report submitted from your end vide letter dated 11.02.2017 it was observed that this report is the same which was submitted vide letter no. nil dated 06 August 2013 and was not accepted by the Central Zoo Authority. Accordingly, the Technical Committee of the Central Zoo Authority in its 83rd Meeting held on 19.05.2017 decided not to consider your request as the project work has not been carried out as per the MoU. Further, the committee also considered the project as closed since the Madras Crocodile bank Trust, Mamallapuram has surrendered the earlier released grant amounting Rs. 1,42,267/- towards the project. The Madras Crocodile bank Trust has not paid penal interest at a rate of 10% per annum as per provisions under Rule No. 258(1) of GFR, 2017, for the amount Rs. 1,42,267/- released on 15.12.2010.

Keeping in view of the above, you are requested to submit the penal interest from 15.12.2010 at the rate of 10% per annum against the grant of Rs. 1,42,267/- released towards the project to this authority. The amount may be deposit/transferred to the Central Zoo Authority through RTGS as per the details below:
