Research:

Preparation and Maintenance of National Studbooks of sloth bear

The committee approved the grant of Rs. 17,76,145 for five year period for the preparation and updating studbooks of sloth bear, Himalayan black bear, Brown bear and Malayan sun bear housed in the Indian zoos as per the details given below:

The committee also recommended that same studbooks will also be supplied to WII by Wildlife SOS apart from CZA. The CZA will be main hub for all the studbooks whereas Wildlife Institute of India Dehradun will work as sub-hub for the said studbooks.

II. Publication of Newsletter on Zoos by CZA

The committee approved the proposal for publishing a Newsletter on Zoos through outsourced firm/organization who will directly collect the information from the zoos and publish the same under the supervision of CZA. The CZA will constitute an editorial board for editing the news to be published in the Newsletter. This Newsletter on Zoos will have information on important events of zoos such as birth of endangered species, zoo education programme, adoption schemes in zoos, awareness campaign in zoos, CZA, and zoo announcements, zoo news, and circular etc. The committee also recommended that the last few pages of the Newsletter should be dedicated for coverage of global news relating to foreign zoos, and may be designated as Global News Section.

The proposed Zoo Newsletter will be in colour and published quarterly with 500 hard copies. The Newsletter will also be uploaded on the CZA website for wider dissemination. The Newsletter will have 20 pages ($8.5\ \times\ 11'$) with thickness of 170 GSM. The expenditure (tentatively Rs. 4-5 lakhs) to be incurred on the publishing of the said Newsletter will be met from the CZA's grant in aid.

III. Study on utilization pattern of enclosures by sloth bear and enrichment requirement in non-conventional captivity

The committee in principle approved the proposal on conducting study at Sloth Bear Rescue Facility at Agra for two year period. To avoid the duplication of efforts, it was recommended that Wildlife Institute of India Dehradun and Wildlife SOS should conduct the study jointly in collaborative framework and revise estimates if necessary to make adjustment for resources already available. The Committee authorized the MS, CZA to take the final decision on the subject after receipt of information from the project proposent and WII.

IV. Developing zoo educator's kit for conservation education (CE) for South Asia including an education manual for educators and a CD

The Committee approved the grant of Rs. 12.21 lakhs for developing zoo educator's kit including education manual for the zoo educators as per the details given below:
