

## MINISTRY OF ENVIRONMENT AND FORESTS

New Delhi, the 15th November 1995.

S.O. M.31.—In exercise of the powers conferred by clause (e) of sub-section (1) of section 3, read with sub-section (7) of section 38B of the Wild Life (Protection) Act, 1972 (53 of 1972), the Central Government hereby makes the following rules to amend the Central Zoo Authority (Officers and Other Employees) Recruitment Rules, 1991, namely :—

1. (i) These rules may be called the Central Zoo Authority Officers and (Other Employees) Recruitment (Amendment) Rules, 1995.
- (ii) They shall come into force on the date of their publication in the Official Gazette.
2. In the Schedule to the Central Zoo Authority (Officers and Other Employees) Recruitment Rules, 1995:—
  - (a) in column 13 of serial number 6, 7, 8, 9 and 10, for the existing entry at item number 2, the following entry shall respectively be substituted, namely :—
 

"2 An Officer of the Ministry of Environment and Forests not below the rank of Deputy Secretary";
  - (b) after serial number 5 relating to the post of Accountant and the entries relating thereto, the following serial number and the entries shall be inserted, namely :—

Educational and other qualifications required for direct recruits

6 Between 18 and 30 years relaxable upto 40 years (upto 45 years in respect of Scheduled Caste/Scheduled Tribe candidates) in case of Government Servants in accordance with the instructions or orders issued by the Central Government.

7 Not applicable

Essential —

(i) Degree of a recognised University with Science/Mathematics/Economics/Commerce/Statistics.

Note : The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India (and not the closing date prescribed for those in Assam,

(ii) Diploma/Certificate in Computer Application from a recognised institution.

Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh division of Jammu and Kashmir State, Labaul Spiti district and Pangi sub-division of Chamba district of Himachal Pradesh, Andaman and Nicobar Islands or Lakshadweep).

Desirable —

One year experience in programming, System operations and analysis.

Whether academic and educational qualifications prescribed for direct recruits will apply in the case of promotions.

Period of probation, Method of recruitment whether by direct recruitment or by promotion or by deputation/transfer and percentage of the vacancies to be filled by various methods.
