Terms of Reference:

- a. The Internal Committee will discharge the functions in terms of the provisions of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, and Rules notified thereunder.
- b. The Internal Committee will enquire into all complaints of sexual harassment at the workplace pertaining to this Office filed either in the SHe-Box portal (www.shebox.nic.in) or otherwise and submit its recommendation / report to the competent Disciplinary Authority in the Office of the Central Zoo Authority in a timely manner.
- c. The Presiding Officer and every Member of the Internal Committee shall hold Office for such period, not exceeding three years, with effect from the date of issuance of this Order or till further orders whichever is earlier.

- d. Shri Vivek Goel, Data Processing Assistant is also nominated to work as the Convenor of the Internal Complaints Committee.
- e. The non-official Member of the Internal Committee shall be paid such fee or allowances for holding the proceedings of the Internal Committee, by the employer as prescribed under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rules, 2013.
- f. The Internal Committee shall prepare minutes of the proceedings of every meeting. The minutes should contain the date of meeting and serial number so that it is possible to gauge the number of meetings held during the inquiry. The minutes should also contain names of members present along with their signature.
- g. The Internal Committee shall furnish prescribed Annual Report of the number of complaints filed and action taken, to the Member Secretary, Central Zoo Authority, to ensure its inclusion in the Annual Report of the Central Zoo Authority as a statutory obligation.
- h. It is desirable that the Internal Committee to meet once in a quarter even if there is no live case and review preparedness of this Office to fulfill requirements specified for the Internal Committee in the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and to assist this Office in generating awareness and taking preventive steps in order to ensure that the work environment is conducive to the participation of women employees.
