**General instructions**

1. The officers/officials selected will be posted as DIG at Delhi, Jaipur, Nagpur, Guwahati & Hyderabad.
2. The name of the post applied for may be written in bold letters on the top of the envelopes and the bio-data.
3. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of Central/State Government shall not ordinarily exceed **five years for the post of Deputy Inspector General.**
4. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.
5. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.
6. The deputation rules, regulations and provisions as issued from time to time by DoPT shall be applicable.
7. Applications received after the last date and incomplete application will not be considered.
