

  - 4.** Reducing tourist pressure on the Gir PA by providing an alternate place for wildlife Safari.

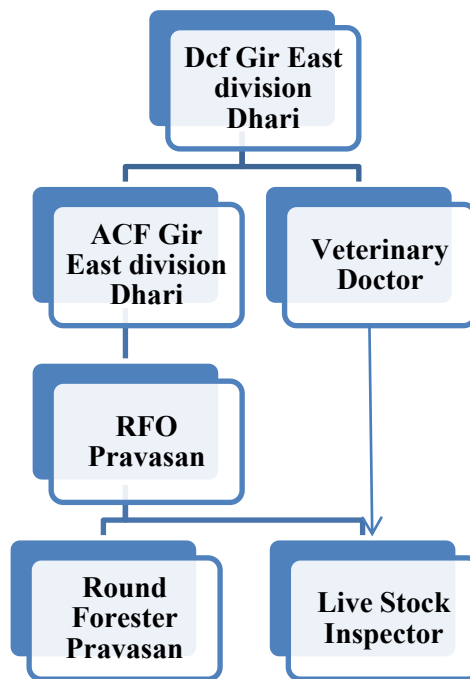
