### Statutory Annual Report of Kuanria Deer Park for the Year 2016-17

#### Introduction: -

Kuanria Deer Park has been established during the year 1985 by taking 8 Nos. of spotted deer (Axis-axis). The area of the said park is 6.0 acres. It is situated 7KMs from Daspalla Block Head Quarters and 47KMs from District headquartersNayagarh & 133 KMs from State Capital Bhubaneswar.

#### Administrative& staffing pattern:-

The deer park is under the jurisdiction of Banigochha East Wildlife Range of Mahanadi Wildlife Division. The forester of Takera section is in-charge of the Deer Park &one temporary status employee has been engaged to supervise the work of watchers engaged in the park. Besides 10 nos. of daily wages watchers have been engaged to supply green fodder to the animals of the Deer Park.

#### **Upkeep and Health care of the Animal:-**

The Deer Park consists of 246nos. of spotted deer (Axis-axis). The watchers engaged in Deer Park cleaned the enclosure and feed deer mash to the animals. They also supply green fodder to the animals twice a day. The quantity of deer mash is supplied to animals is 1.8 quintals per day (54.0 quintals per month).

The Block Veterinary Officer, Dasapalla inspects the Deer Park once in a week at every Sunday. The excreta of the animal is removed promptly from feeding cells and kraals by the watchers. As per direction of veterinary officer, Dasapalla the feeding cells and kraals are washed and disinfected every day. Besides the topsoil of the enclosure has been removed at 6-inch depth and the soil from outside area has been filled in the said place once in every two years. The spreading of shell line is double on the surface of the enclosure once in every month.

#### Veterinary infrastructure facilities: -

Quarantine and treatment of animals is taken up in the Deer Park by Block Veterinary Officer, Dasapalla and his staff as and when required as the distance of Dasapalla veterinary dispensary is 7 KMsawayfrom the Deer park.

### **Development Andplanning: -**

A compound wall in the front side of Kuanria, Deer Park has been constructed for safety of the animal. One main gate has beenconstructed at the centre of deer Park. Besides RCC designed fencehas been constructed over 710 Rft on the front side of the enclosure. A green hedge fence has been created in between RCC designed fence and galvanised iron chain linked mesh in the front side of enclosure. A cattle proof trench has also been excavated 50 Mtrs away around the Deer Park not to allow any domestic animal near to the deer park.

### Animal housing, Display of animal and Animal enclosure: -

The animal enclosure has been divided into two parts, which are surrounded by G.I. chain linked mesh fence. Again, for safety of the animals 710 Rft RCC designed fence has been constructed. Besides one compound wall has been constructed in the front side of the Deer Park. A children park has been developed in between compound wall and RCC designed fence i.e. outside of the enclosure.

In case of death of the animal, the post mortem carried out by BVO, Dasapalla to accretion the reason of death. In most cases the death is caused due to fighting between adult male members.

A record on birth & death of animal has been maintained. The detail of the abstract is annexed here with for kind reference.

During summer season, temporary sheds are constructed within the enclosure to provide shed for the animal.

The Forester in-charge of the Deer Park along with the engaged temporary status monitor the overall health of the captive animals during the stress hours from 12.00 noon to 3.00 pm. Security of animals is ensured during night hours by deployment of watchers inside park.

Lighting arrangements has been done at the boundary of Deer Park as well as inside the Deer Park. Water facility has been provided to the Park by means of Bore well and drinking water is provided to each enclosure by means of pipe to the water tanks.

### Population control measure: -

Population control measures have been taken up by way of segregation of the male and female in separate enclosure. At the end of  $31^{st}$  March 91 nos. of male spotted deer and 155 nos. female spotted deer are found during inventory.
