Annual Activities for the year : 2016-17

Establishment : The Mini Zoo , Roing was established in the year 1985.

Evaluation and Recognition: The Mini Zoo, Roing was evaluated by Shri. R.C. Bhattacharjee on 17/4/2015. After evaluation, the Central Zoo Authority has decided to grant renewal of recognition to Mini Zoo, Roing, Arunachal Pradesh as "Mini Category Zoo" under Section 38H of Wildlife (Protection) Act, 1972 for a period up to 31/1/2016 on certain conditions vide your letter No. F.No.19-96/93-CZA(29)(M)(NS)/7585 dtd. 14/08/2015. Now, necessary proposal has already been submitted for renewal of recognition of Mini Zoo beyond the period from 31/01/16 vide this office letter No. D-05/2013/1117-18 dtd. 23/02/16. Shri. Narayan Mahanta, IFS has deputed for the evaluation of the Mini Zoo, Roing vide your letter No. F.No.19-96/93-CZA(29)(Vol.I)(AK)/294/2017 dtd. 15/02/2017. But the evaluation has not yet been done.

Annual Activities :-

1. Master plan of Mini Zoo, Roing has submitted vide this office letter No.D-05/2013/664 dtd 17/10/2015.
2. A trained Dy. Forest Ranger looks after the day to day management of the Zoo on full time basis.
3. Animal have been provided with enclosures and improvised cubicle for feeding/retiring.
4. Vegetative screening has been provided with between the adjacent enclosures to reduce anxiety & stress to the animals.
5. The enclosures are enriched environmentally with the existing laborers & resources. There is acute shortage of fund.
6. Timely supply of wholesome and unadulterated food in sufficient quantity to each animal is regulated throughout the year.
7. Health & hygiene of animals, enclosures & Zoo premises are closely monitored with Veterinary Officer.
8. District Veterinary Centre is being liaison to depute one Veterinary Doctor to look after the affairs of the Mini Zoo, Roing.
9. The trainees of APFTI, Roing were imparted training on Zoo management in Zoo premises.
10. All records are being maintained and posted upto date.




