ORDER [UNDER SECTION 38-H(6) OF THE WILD LIFE (PROTECTION) ACT, 1972]

Subject: Cancellation of recognition of the Childrens' Park cum Mini Zoo, Ballari, Karnataka - regarding

Whereas, recognition of the Childrens' Park cum Mini Zoo, Ballari under Section 38-H of the Wild Life (Protection) Act, 1972, was valid till 23rd January, 2019. Application for renewal of recognition of the Childrens' Park cum Mini Zoo, Ballari is not received in this office. A team comprising Shri B. S. Bonal, IFS (Retired) and Shri Lakshminarasimha, Scientific Officer, CZA, as deputed by the CZA has inspected the zoo on 4th and 5th March, 2020.

- 2. And whereas, the evaluating officers reported that the Childrens' Park cum Mini Zoo, Ballari has been closed by shifting animals to new site.
- 3. And whereas, the Chief Wildlife Warden, Karnataka vide his letter No.PCCF(WL)/F/CR-14/2014-15 dated 29th April, 2020, informed that the Children's Park cum Mini Zoo, Ballari was closed to public on 15th November, 2019 and the land was handed over to the Karnataka Forest Department on 12th February, 2020.
- 4. And whereas, above mentioned facts were placed before the Technical Committee of the CZA in its 96th Meeting held on 30th July, 2020. Members of the Technical Committee perused the Report and recommended to the Central Zoo Authority for cancellation of recognition of the Childrens' Park cum Mini Zoo, Ballari.
- 5. And whereas, the Central Zoo Authority in its 37th Meeting held on 7th December, 2020, taken note of the transfer of captive animals and physical closure of the Childrens' Park cum Mini Zoo, Ballari. In view of grounds cited above and in exercise of powers conferred under sub-section (6) of Section 38-H under the Wild Life (Protection) Act, 1972, decided to cancel recognition of the Childrens' Park cum Mini Zoo, Ballari. Now, therefore, recognition of the Childrens' Park cum Mini Zoo, Ballari is hereby cancelled.

Sir,

Please refer to your letter dated 20.12.2002No. SAS-Zoo-enewal_CR-136/2000-01, dated 19.12.2000 seeking renewal of recognition to Children's Park and Mini Zoo at Bellary.

It is bring into in to your kind notice that the Central Zoo Authority vide its letter No. 19-80/93-CZA(104)(N), dated 19.06.2002 and letter dated 6.6.2003 had communicated that as per the decision taken in the Technical Committee of the Central Zoo Authority, the Bellary Zoo is to be shifted to a new site, for which this Authority has conveyed no objection subject to the condition that you have obtained the clearance from the Ministry of Environment & Forests under the Forest Conservation Act laid vide aforesaid letter.

In this connection, it was decided that since the zoo at Bellary in process of relocation to proposed site at Bilikal Reserve Forest near Kamlapur, Bellary, you may like to continue to operate the zoo at the existing zoo till 31st March, 2007 subject to the following conditions:-

1. The State Government of Karnataka should take final decision to shift all the animals to proposed site and close the existing the facility since the total area of the present zoo is inadequate (2.44 hectares only).

2. This interim recognition is granted subject to the condition that zoo operator should comply with the conditions stipulated vide this office letter No. 19-80/93-CZA(104)(Vol. II), dated 15.09.2004.

- The State Government should ensure that zoo at new site shall have a 6. full time Officer-in-Charge, solely responsible for looking after the upkeep of animals and maintenance of animal enclosures. The zoo should also have one full time veterinarian with minimum qualification of B.V.Sc. & A.H.
- The zoo at new site should follow the norms and standards as laid 7. down in the "Recognition of Zoo Rules".

A half yearly report regarding progress made in implementation of the aforesaid conditions should be submitted to the Central Zoo Authority.

The Central Zoo Authority may consider granting further permission to continue to operate at the existing site depending on the progress made by the State Government in relocation of existing zoo to the new site.
