Whereas, the recognition of the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana under Section 38H(1) of the Wild Life (Protection) Act, 1972 vide letter F. No. 19-128/93-CZA(16)(NS)/933/2016, dated 21.06.2016 was valid up to 05.05.2017 subject to the compliance with the conditions specified therein under Recognition of Zoo Rules, 2009.

Whereas, the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana was evaluated by Shri T. Ajay Kumar, Evaluation and Monitoring Assistant, CZA on 20.04.2017.

Whereas, the evaluation report of the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana was placed before the Technical Committee of the CZA in its 84<sup>th</sup> Meeting held on 19.09.2017.

Whereas, the Technical Committee of the CZA after detailed deliberations recommended to issue a Show Cause Notice to the operator of the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana.

Whereas, the CZA vide its letter F. No. 19-128/93-CZA(16)(Vol. I)(AK)/1710/2017, dated 20.10.2017 issued Show Cause Notice to the Operator of Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana under the provisions of Section 38H(6) of the Wildlife (Protection) Act, 1972, and provided an opportunity of hearing to the Operator of the Zoo under Section 38-H(6) of the Wild Life (Protection) Act, 1972 was provided on 07.06.2018.

Whereas, the opportunity of hearing was not availed by the zoo operator but a written reply was filed by the zoo operator.

Whereas, the matter was placed before the Technical Committee of the CZA in its 85<sup>th</sup> Meeting held on 23<sup>rd</sup> March, 2018. After due deliberation on the reply filed by the Operator of the Zoo, the Technical Committee of the CZA decided to provide one more opportunity of hearing to the Zoo Operator.

Whereas, an opportunity of hearing was once again provided to the zoo operator on 10.07.2018.

Whereas, the opportunity of hearing was once again not availed by the zoo operator.

Whereas, the Technical Committee in its 86<sup>th</sup> meeting held on 28<sup>th</sup> September, 2018 recommended to the Central Zoo Authority to cancel recognition to the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana as per provisions of Section 38H(6) of the Wildlife (Protection) Act, 1972 keeping in view welfare of the captive animals.

Whereas, the Central Zoo Authority in its 32<sup>nd</sup> meeting held on 19<sup>th</sup> November, 2018, in view of the failure of the operator of the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana to comply with conditions stipulated by the CZA, approved the recommendation of the Technical Committee and decided to cancel the recognition of the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana under Section 38H(6) of the Wildlife (Protection) Act, 1972.

Now, therefore, having been given sufficient opportunity, the recognition of the Sanghi Mini Zoo, Koheda, Ranga Reddy District, Telangana is hereby cancelled as per provisions laid down in Section 38H(6) of the Wildlife (Protection) Act, 1972 with a provision to file an appeal before the Central Government as per provisions laid down in Section 38H(7) of the Wildlife (Protection) Act, 1972.

Reference is invited to above cited correspondence, it is to inform that the evaluation of the Sanghi Deer Park, Ranga Reddy District, Telangana was carried out by Dr. Brij Kishor Gupta on 29.02.2016. The evaluation report of the Sanghi Deer Park, Ranga Reddy District, Telangana as submitted by the evaluating officer was considered by the Technical Committee in its 78<sup>th</sup> Meeting held on 6<sup>th</sup> May, 2016.

The Technical Committee has decided to issue Show Cause Notice under Section 38H (5&6) of the Wild Life (Protection) Act, 1972 to Sanghi Deer Park, Ranga Reddy District, Telangana for non-compliance with conditions stipulated by the Central Zoo Authority in violation of Recognition of Zoo Rules, 2009 (amended in 2013) and to provide time period of three months to the zoo to file a reply to the Show Cause Notice and to submit an action taken report on issues mentioned in the Show Cause Notice. The Show Cause Notice is being issued separately

Besides, the Committee has decided to grant renewal of recognition under Section 38H of the Wild Life (Protection) Act, 1972 to Sanghi Deer Park, Ranga Reddy District,

Telangana for a period of one year. The renewal of recognition to Sanghi Deer Park, Ranga Reddy District, Telangana as a "Mini category Zoo" under Section 38H of the Wild Life (Protection) Act, 1972 is for a period up to 05.05.2017 subject to the compliance of the following directives under the Recognition of Zoo Rules, 2009 (amended in 2013) and mid-term evaluation of the zoo:-
