Sir/Madam,

With reference to above, I am directed to inform that the recognition of Deer Park, Chittoor, Andhra Pradesh was accorded up to August 19<sup>th</sup>, 2021 vide reference no. 3 above. The application for the renewal of recognition of Deer Park, Chittoor, Andhra Pradesh for the period beyond August 19<sup>th</sup>, 2021 was received by this office vide reference no. 2 above.

Ms. Shruti Sharma, IFS (Retd.) was deputed by this office to carry out the evaluation of the Deer Park, Chittoor, Andhra Pradesh vide CZA letter at reference no. 1 above. The zoo was accordingly evaluated on September  $12^{th}$  2022.

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 107<sup>th</sup> meeting of the Technical Committee of the Central Zoo Authority held on April 19<sup>th</sup>, 2023. The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the

renewal of recognition of Deer Park, Chittoor, Andhra Pradesh for a period of two years and to regularise the period after August 19<sup>th</sup>, 2021, subject to compliance with observation/ recommendation in the table below and midterm evaluation. The members also recommended that the zoo operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of  $107^{th}$  Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August  $19^{th}$ , 2021 and renewed the recognition of Deer Park, Chittoor, Andhra Pradesh for a period up to May 23, 2025 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

Further, half yearly report regarding progress made in the implementation of the aforesaid conditions should also be submitted to the Central Zoo Authority.

The recognition of Deer Park, Chittoor, Andhra Pradesh for the period beyond May 23, 2025 would be considered on the basis of compliance of the conditions stated above, mid-term evaluation and general performance of the zoo.

The recognition of Deer Park, Chittoor, Andhra Pradesh shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.

This issues with the approval of the competent authority.

Sir,

With reference to above, the undersigned is directed to inform that recognition of the Deer Park, Chittoor, Andhra Pradesh under Section 38-H of the Wild Life (Protection) Act, 1972, was suspended till 3<sup>rd</sup> January, 2020. Shri Sanjay P Thakre, IFS (Retired), evaluating officer deputed by this office has evaluated the zoo on 23<sup>rd</sup> February, 2020. Copy of the Evaluation Report is enclosed herewith for your perusal and needful action.

2. Evaluation Report of the Deer Park, Chittoor was placed before the Technical Committee in its 96<sup>th</sup> Meeting held on 30<sup>th</sup> July, 2020. The Technical Committee, after detailed deliberation, observed that action taken by the Deer Park, Chittoor on grounds cited for suspension of recognition is not satisfactory and recommended to serve notice to the Deer Park, Chittoor under Section 38-H(6) of the Wild Life (Protection) Act, 1972. Also, to ensure that the zoo does not continue to operate without recognition, it was recommended to the Central Zoo Authority to grant recognition of the Deer Park, Chittoor, for a period of one year, subject to compliance with conditions therein and mid-term evaluation.

3. This office issued Office Memorandum F.No.7-10/2020-CZA(PART-I) dated 25<sup>th</sup> August, 2020 regarding renewal of recognition of the zoo. Subsequently, the Central Zoo Authority, in its 37<sup>th</sup> Meeting held on 7<sup>th</sup> December, 2020, in exercise of powers conferred under sub-section (1), (3) and (4) of Section 38-H under the Wild Life (Protection) Act, 1972, approved recommendation of the Technical Committee. Also, the notice under Section 38-H(6) of the Wild Life (Protection) Act, 1972 is being issued separately.

4. The Central Zoo Authority has renewed recognition of the Deer Park, Chittoor as a Mini Zoo for a period up to **19<sup>th</sup> August, 2021** subject to compliance with following conditions as per the Recognition of Zoo Rules, 2009 (RZR) and mid-term evaluation of the zoo.

# Sub:- Grant of renewal of recognition to the Deer Park, Chittoor beyond 31.3.2007 under Section 38H of the Wild Life (Protection) Act -Regarding.


Sir,

Reference is invited to your application No. 114/2003/G4 dated 09.06.2007 seeking grant of renewal of recognition for Deer Park, Chittoor beyond 31.3.2007 under Section 38H of the Wild Life (Protection) Act, 1972.

The evaluation report of the Deer Park, Chittoor as submitted by the evaluating officer Dr. N. Krishna Kumar, Conservator of Forests (P&D), Chennai was considered by the Technical Committee of Central Zoo Authority in its meeting held on 16.07.2007.

The Central Zoo Authority has decided to grant conditional recognition to Deer Park, Chittoor as a mini category zoo under Section 38H of the Wild Life (Protection) Act, for a period up to 31.08.2009 subject to the compliance of the following directives under the Recognition of Zoo Rules, 1992:-

1. The Zoo shall prepare a theme based long-term (for a minimum period of 10 years) master plan for its development including a management plan for next six years giving details of the proposals and activities of development during the period. The copies of the said plan shall be sent to the Central Zoo Authority.

- 2. Create/ modify/ improve animal housing (for the targeted species identified under the master plan), veterinary facilities, boundary wall as well as fulfill other conditions prescribed under Rule 10 of Recognition of Zoo Rules, 1992.
- 3. The Zoo Operator should increase the area of the Deer Park to minimum 10 hectares.
- 4. The Zoo should be encompassed by atleast 2 meter high chainlink fence of appropriate design and dimensions.
- 5. Necessary budgetary provisions should be made by the State Government for meeting the expenses towards upkeep and maintenance of animals in the Deer Park.
- 6. A full time Officer-in-charge at the Deer Park should be deputed. The deputed Officer-in-charge shall be delegated adequate administrative and financial powers to purchase feed and medicine and carryout emergency repair of animal enclosures, as may be necessary for proper upkeep and care of the zoo animals.
- 7. All animal enclosures in the Zoo shall be so designed as to ensure the safety of animals. Stand off barriers and adequate warning signs should be provided for keeping the visitors at the safe distance of the animals.
- 8. The Zoo Operator should construct an appropriate treatment room in the premises of the Deer Park, where routine examination and treatment of sick animals can be undertaken.
- 9. The number of Spotted deer displayed at the Deer Park shall be kept within the carrying capacity of the enclosure and at any point of time the number should not go beyond its carrying capacity. Necessary control measures should be taken for the prolifically breeding species particularly for Spotted deer.
- 10. The Zoo Operator should ensure timely supply of wholesome and unadulterated food in sufficient quantity to each animal. The feed should be stored in an appropriate rodent free feed room and Zoo Operator should also make available round a clock supply of portable water for drinking purposes in each enclosure.

- 11. The Zoo Operators shall submit the annual inventory report giving details of births, deaths, acquisition and disposal to the Central Zoo Authority within 30<sup>th</sup> April for each financial year.
- 12. The Zoo Operator shall provide a sign board displaying scientific information regarding the animals housed therein.
- 13.A quarterly report regarding progress made in implementation of the aforesaid directive be submitted to Central Zoo Authority.

Further renewal of recognition to Deer Park, Chittoor beyond <u>31.08.2009</u> will be considered on the basis of compliance of the directives stated above and physical evaluation of the zoo at that point of time.

The recognition to the Deer Park, Chittoor shall be revoked by the Central Zoo Authority, at any point of time if the Zoo Operator is found not complying with the stipulated conditions.
