#### Sir/Ma'am,

The renewal of recognition of Sarnath Deer Park, Varanasi, Uttar Pradesh was accorded up to 19/8/2021 vide (2). Subsequently, the application for the renewal of recognition of Sarnath Deer Park, Varanasi, Uttar Pradesh for the period beyond 19/8/2021 was received vide (1). Subsequently, the said zoo was evaluated by Dr. Devender Kumar, Evaluation and Monitoring Officer, CZA on 20/8/2021 & 21/8/2021.

2. The evaluation report was deliberated in the 103<sup>rd</sup> meeting of the Technical Committee held on 10/2/2022. The committee upon deliberation recommended for renewal of recognition of Sarnath Deer Park, Varanasi, Uttar Pradesh (Category: Mini Zoo) for a period of two years and to regularize the period after 19/8/2021, subject to compliance with conditions therein and midterm evaluation.

3. Subsequent to the approval of the recommendation of the Technical Committee by the Chairperson, Central Zoo Authority, the recognition of Sarnath Deer Park, Varanasi, Uttar Pradesh (Category: Mini Zoo) is renewed for a period

up to 28/2/2024 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. The period after 19/8/2021 until the date of issue of this letter is also regularized. This is subject to the ratification of this decision in the next meeting of the Governing body of the Central Zoo Authority. The renewal is subject to the relevant provisions of the Wild Life (Protection) Act, 1972, the Recognition of Zoo Rules, 2009, extant guidelines of the CZA, compliance of the conditions stipulated below and mid-term evaluation:

6. The recognition of Sarnath Deer Park, Varanasi, Uttar Pradesh shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.
