Sir/Madam,

With reference to above, I am directed to inform that the recognition of Van Prani Udyan, IVRI, Izatnagar, Bareilly, Uttar Pradesh was accorded up to August 19<sup>th</sup>, 2021 vide reference no. 3 above. The application for the renewal of recognition of Van Prani Udyan, IVRI, Izatnagar, Bareilly, Uttar Pradesh for the period beyond August 19<sup>th</sup>, 2021 was received by this office vide reference no. 2 above.

Shri Pawan Kumar, IFS (Retd.) was deputed by this office to carry out the evaluation of Van Prani Udyan, IVRI, Izatnagar, Bareilly, Uttar Pradesh vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on May 10<sup>th</sup>, 2022.

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 106<sup>th</sup> meeting of the Technical Committee of the Central Zoo Authority held on September 27<sup>th</sup>, 2022. The Technical Committee after detailed deliberations

recommended to the Central Zoo Authority for the renewal of recognition of Van Prani Udyan, IVRI, Izatnagar, Bareilly, Uttar Pradesh for a period of two years and to regularise the period after August 19<sup>th</sup>, 2021, subject to compliance with observation/recommendation in the table below and mid-term evaluation. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of 106<sup>th</sup> Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August 19<sup>th</sup>, 2021 and renewed the recognition of Van Prani Udyan, IVRI, Izatnagar, Bareilly, Uttar Pradesh for a period up to December 14<sup>th</sup>, 2024 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

The recognition of Van Prani Udyan, IVRI, Izatnagar, Bareilly, Uttar Pradesh shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.

Grant of recognition beyond 31<sup>st</sup> January, 2016 to the Van Prani Udyan, IVRI, Izatnagar as a 'Mini Category Zoo' would be considered on the basis of compliance of the conditions stated above, general performance and physical evaluation of the zoo.

The recognition to the Van Prani Udyan, IVRI, Izatnagar as shall be revoked by the Central Zoo Authority, at any point in time if the Zoo Operator is found not complying with the stipulated conditions.
