#### Sir/Madam,

With reference to above, I am directed to inform that the recognition of North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal was accorded up to August 19<sup>th</sup>, 2021 vide reference no. 3 above. The application for the renewal of recognition of North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal for the period beyond August 19<sup>th</sup>, 2021 was received by this office vide reference no. 2 above.

Sh. B. K. Singh, IFS (Retd.) was deputed by this office to carry out the evaluation of the North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on June 6, 2022.

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 106<sup>th</sup> meeting of the Technical Committee of the Central Zoo Authority held on September 27<sup>th</sup>, 2022. The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the renewal of recognition of North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal for a period of two years and to regularise the period after August 19<sup>th</sup>, 2021, subject to compliance with observation/ recommendation in the table below and mid-term evaluation. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report

with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of 106<sup>th</sup> Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August 19<sup>th</sup>, 2021 and renewed the recognition of North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal for a period up to December 15, 2024 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

any land constraints. It has ample space for construction of new animal enclosures (in accordance with the CZA protocol). The park offers an excellent public amenity such as Children play area, Souvenir shop, Solar operated mobile stations, Biodiversity Museum, Food Court, Amphitheatre, Canteen, cloak room, baby care room, visitor waiting hall, Nature Interpretation centre etc. The park has recently introduced adventure sports facilities such as long & short zip line, Burma bridge, wall climbing activities & other developmental projects are in the pipeline. The park has also developed a butterfly garden with rearing facility & kiosk centre for the students, researchers etc.

A compliance report to the Central Zoo Authority on implementation of the aforesaid observation/ recommendation shall be submitted by the zoo within three months of issue of this letter. Further, half yearly report regarding progress made in the implementation of the aforesaid conditions should also be submitted to the Central Zoo Authority.

The recognition of North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal for the period beyond December 15, 2024 would be considered on the basis of compliance of the conditions stated above, mid-term evaluation and general performance of the zoo.

The recognition of North Bengal Wild Animals Park, Salgura (Bengal Safari), West Bengal shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.

This issues with the approval of the competent authority.

Reference is invited to above cited correspondence. It is to inform that the evaluation of the North Bengal Wild Animals Park (Bengal Safari), Salugara, Siliguri, West Bengal, was carried out by Shri Bipul Chakrabarty, Director, Tata Steel Zoological Park, Jamshedpur on 13.04.2017.

The evaluation report of the North Bengal Wild Animals Park (Bengal Safari), Salugara, Siliguri, as submitted by the evaluating officer was considered by the Technical Committee in its 83<sup>rd</sup> Meeting held on 19.05.2017. As decided by the Technical Committee, Show Cause Notice dated 28.06.2017 was served on operator of the North Bengal Wild Animals Park (Bengal Safari), Salugara, Siliguri. In response, the Director, North Bengal Wild Animal Park vide letter dated 11.07.2017 submitted therewith a time bound commitment for compliance with observations made by the Technical Committee of the Central Zoo Authority.

The reply received from the Director, North Bengal Wild Animal Park was placed before the Technical Committee in its 84<sup>th</sup> Meeting held on 19.09.2017. After detailed deliberations and on perusal of the reply, the Technical Committee has recommended to the Central Zoo Authority for renewal of recognition of the North Bengal Wild Animals Park (Bengal Safari), Salugara, Siliguri (Mini Category Zoo), for a period of two years.

The Central Zoo Authority in its 30<sup>th</sup> Meeting held on 28.09.2017, approved the recommendation of the Technical Committee. The Central Zoo Authority in exercise of powers conferred under Section 38H(1), (3) and (4) of the Wildlife (Protection) Act, 1972, has decided to renew recognition to the North Bengal Wild Animals Park (Bengal Safari), Salugara, Siliguri (Mini Category Zoo), for a period of two years and to regularize the period after 05.05.2017.

The renewal of recognition to the North Bengal Wild Animals Park (Bengal Safari), Salugara, Siliguri as "a Mini Category Zoo" is for a period up to 27<sup>th</sup> September, 2019 subject to the compliance of the following conditions stipulated as per the Recognition of Zoo Rules, 2009, vide Notice F.No.22-64/2004-CZA(Vol.I)(461)(BKG)/1182/2017 dated 28.06.2017 and mid-term evaluation of the zoo:
