Sir,

With reference to above, it is to inform that the application for the recognition of Meghalaya State Zoo, Umtrew, Shilong, Meghalaya as received by this office vide reference no. 2 above.

Dr. Devender Kumar, Evaluation and Monitoring Officer, Central Zoo Authority was deputed by this office to carry out the evaluation of the Meghalaya State Zoo, Umtrew, Shilong, Meghalaya vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on June 18, 2023.

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 108th meeting of the Technical Committee of the Central Zoo Authority held on June 23 rd, 2023. The Committee observed that finishing work is still going on at Meghalaya Biological Park, Umtrew, Meghalaya. Also, the CZA vide its letter issue no. I/47065/2023 dated 23.06.2023 has communicated the observation on revised application under Sub-section (2) of Section 38-H of the Wild Life (Protection) Act, 1972 for recognition of the zoo and reply is still awaited.

The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the recognition of Meghalaya State Zoo, Umtrew, Shilong, Meghalaya for a period of two years and, subject to compliance with observation/ recommendation in the table below and to the observation communicated vide letter issue no. 23.06.2023 and mid-term evaluation.

The Committee also recommended to the CZA for approval of closure of Lady Hydari Park cum Mini Zoo, Shillong, Meghalaya (old site) once the Meghalaya Biological Park, Umtrew, Meghalaya (new site) becomes operational and subsequent shifting of animals from old site to new site. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while recognition.

Accordingly, the office of the Central Zoo Authority hereby communicate the grant of the recognition of Meghalaya State Zoo, Umtrew, Shilong, Meghalaya for a period up to July 30, 2025 under Section 38-H (1,3,4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

A compliance report to the Central Zoo Authority on implementation of the aforesaid observation/ recommendation shall be submitted by the zoo within three months of issue of this letter. Further, half yearly report regarding progress made in the implementation of the aforesaid conditions should also be submitted to the Central Zoo Authority.

The recognition of Meghalaya State Zoo, Umtrew, Shilong, Meghalaya for the period beyond July 30, 2025 would be considered on the basis of compliance of the conditions stated above, midterm evaluation and general performance of the zoo.

The recognition of Meghalaya State Zoo, Umtrew, Shilong, Meghalaya shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.

This issues with the approval of the competent authority.
