Sir/Madam,

With reference to above, I am directed to inform that the recognition of Dr. Shyama Prasad Mukherjee Zoological Garden, Surat, Gujarat was accorded up to August 19th, 2021 vide reference no. 3 above. The application for the renewal of recognition of Dr. Shyama Prasad Mukherjee Zoological Garden, Surat, Gujarat for the period beyond August 19th, 2021 was received by this office vide reference no. 2 above.

Shri Vikram Singh Gaur, IFS(Retd.),Former PCCF, Jharkhand was deputed by this office to carry out the evaluation of the Dr. Shyama Prasad Mukherjee Zoological Garden, Surat, Gujarat vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on April 4th, 2022 by Shri Vikram Singh Gaur, IFS (Retd.).

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 106th meeting of the Technical Committee of the Central Zoo Authority held on September 27th, 2022. The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the renewal of recognition of Dr. Shyama Prasad Mukherjee Zoological Garden, Surat, Gujarat for a period of two years and to regularise the period after August 19th, 2021, subject to compliance with observation/recommendation in the table below and mid-term evaluation. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of 106th Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August 19th, 2021 and renewed the recognition of Dr. Shyama Prasad Mukherjee Zoological Garden, Surat, Gujarat for a period up to December 22, 2024 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

The recognition of Dr. Shyama Prasad Mukherjee Zoological Garden,

Surat, Gujarat shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.

Reference is invited to above cited correspondence. It is to inform that the evaluation of the Dr. Shyama Prasad Mukherjee Zoological Garden, Surat, Gujarat was carried out by Dr. Brij Kishor Gupta, Evaluation and Monitoring Officer, CZA on 22.07.2017. The evaluation report of the Dr. Shyama Prasad Mukherjee Zoological Garden, Surat as submitted by the evaluating officer was considered by the Technical Committee in its 84th Meeting held on 19.09.2017. After detailed deliberations, the Technical Committee has recommended to the Central Zoo Authority for renewal of recognition of the Dr. Shyama Prasad Mukherjee Zoological Garden, Surat (Medium Zoo Category) for a period of three years.

The Central Zoo Authority in its 30th Meeting held on 28.09.2017, approved the recommendation of the Technical Committee and has decided to renew recognition to the Dr. Shyama Prasad Mukherjee Zoological Garden, Surat for a period of three years. Further, the Authority has also decided to regularise the period after 30.04.2017.

The renewal of recognition to the Dr. Shyama Prasad Mukherjee Zoological Garden, Surat as "a Medium Category Zoo" as per the provisions of Section 38H(1) of the Wild Life (Protection) Act, 1972 is for a period up to 27th September, 2020 subject to the compliance of the following directives under the Recognition of Zoo Rules, 2009 and mid-term evaluation of the zoo:-
