With reference to above, I am directed to inform that the recognition of Rajkot Zoological Park, Rajkot, Gujarat was accorded up to August 19th, 2021 vide reference no. 3 above. The application for the renewal of recognition of Rajkot Zoological Park, Rajkot, Gujarat for the period beyond August 19th, 2021 was received by this office vide reference no. 2 above.

Shri Vikram Singh Gaur, IFS(Retd.),Former PCCF, Jharkhand was deputed by this office to carry out the evaluation of the Rajkot Zoological Park, Rajkot, Gujarat vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on April 5th, 2022.

The evaluation report (copy enclosed) as submitted by the evaluation officer was

deliberated in the 106th meeting of the Technical Committee of the Central Zoo Authority held on September 27th, 2022. The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the renewal of recognition of Rajkot Zoological Park, Rajkot, Gujarat for a period of two years and to regularise the period after August 19th, 2021, subject to compliance with observation/ recommendation in the table below and midterm evaluation. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of 106th Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August 19th, 2021 and renewed the recognition of Rajkot Zoological Park, Rajkot, Gujarat for a <u>period up to December 7th, 2024</u> under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

The recognition of Rajkot Zoological Park, Rajkot, Gujarat for the <u>period beyond</u> <u>December 7th, 2024</u> would be considered on the basis of compliance of the conditions stated above, mid-term evaluation and general performance of the zoo.

The recognition of Rajkot Zoological Park, Rajkot, Gujarat shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.



Apart from the above, following are suggested to take immediate action:-

The approach to the zoo is very shabby because of encroachment of local residents.
 Action should be taken to modify for better display of entry point.

 The brick masonary established at the outside of zoo located adjacent to herbivore enclosure because of pollution. This should be removed/ closed for better health of the zoo animal.

3. The zoo should establish and notify a society with autonomous governing body for smooth betterment and development works with provision of ploughing back of revenue for development work of the zoo.

4. The zoo should consider to excepte upms of the special pack of works through architects/ mystery viz., formation of rock structures, fimber structures etc.

5. The zoo should consider for continuation of service of engineer for long term basis to harness the experience gained for zoo design and enrichment that is needed.

6. The Zoological Park at new site although open for visitors in 2010, the work is in

progress in case for last three years.

7. Exhibition of new enclosures should be done in the modern concept of the zoo management i.e. conservation exhibits with the larger and open areas with "nature immersing exhibits".

A half yearly report regarding progress made in implementation of the aforesaid conditions should be submitted to the Central Zoo Authority.

Grant of recognition to Rajkot Municipal Zoo, Rajkot beyond 31^{st} July, 2016 as "a Small Category Zoo" would be considered on the basis of compliance of the conditions stated above and general performance of the zoo.

The recognition to the Rajkot Municipal Zoo, Rajkot shall be revoked by the Central Zoo Authority, at any point of time if the Zoo Operator is found not complying with the stipulated conditions.



2. The proposed Blackbuck enclosure may be used to house the Spotted deer and the proposed Spotted deer enclosure shall be used to house Blackbucks since the area proposed is dry in nature and does not have any under ground vegetation.

3. The proposed site for One horned rhinoceros may not be feasible as

the site consist of dry and full hard rock.

You are also requested to ensure that during the given period the zoos should strictly adhere with the standards and norms laid under Recognition of Zoo Rules, 1992.
