Sir,

With reference to above, the undersigned is directed to inform that recognition of the Sarahan Pheasantry, Sarahan, Himachal Pradesh under Section 38-H of the Wild Life (Protection) Act, 1972, was valid till September 28, 2019. Shri Rashmi Kanth Shukla, I.F.S. (Retired), evaluating officer/s deputed by this office has evaluated the zoo on February 29 and March 1, 2020. Copy of the Evaluation Report is enclosed herewith for your perusal and needful action.

- 2. Evaluation Report of the Sarahan Pheasantry, Sarahan, was placed before the Technical Committee in its 96th Meeting held on July 30, 2020. The Technical Committee, after detailed deliberation, made its recommendation to the Central Zoo Authority.
- 3. This office issued Office Memorandum F.No.7-10/2020-CZA(PART-I) dated August 25, 2020 regarding renewal of recognition of the zoo. Subsequently, the Central Zoo Authority, in its 37th Meeting held on December 7, 2020, in exercise of powers conferred under sub-section (1), (3) and (4) of Section 38-H under the Wild Life (Protection) Act, 1972, approved recommendation of the Technical Committee.
- 4. The Central Zoo Authority has regularised the period after September 28, 2019 and renewed recognition of the Sarahan Pheasantry, Sarahan, as a Mini Zoo for a period up to **August 19, 2021** subject to compliance with following conditions as per the Recognition of Zoo Rules, 2009 (RZR) and mid-term evaluation of the zoo.

It is to inform that the evaluation of Pheasantry at Sarahan, Himachal Pradesh was carried out by Dr. Devender Kumar, Scientific Officer, CZA on 10.07.2018. The evaluation report of the Pheasantry at Sarahan, Himachal Pradesh was considered by the Technical Committee in its 86th Meeting held on 28.09.2018. After detailed deliberations, the Technical Committee decided for renewal of recognition of the Pheasantry at Sarahan, Himachal Pradesh for a period of one year. A copy of the evaluation report as submitted by the evaluating officer is enclosed with this letter for your perusal and needful action.

The recommendations of the 86th meeting of the Technical Committee held on 28.09.2018 were placed before the Central Zoo Authority in its 32nd Meeting held on 19.11.2018.
