Sir/Madam,

With reference to above, I am directed to inform that the recognition of Mini Zoo cum Children's Park, Kalaburagi, Karnataka was accorded up to August 19<sup>th</sup>, 2021 vide reference no. 3 above. The application for the renewal of recognition of Mini Zoo cum Children's Park, Kalaburagi, Karnataka for the period beyond August 19<sup>th</sup>, 2021 was received by this office vide reference no. 2 above.

Dr. G. Viswanatha Reddy (Rtd. PCCF & HoFF Rajasthan) was deputed by this office to carry out the evaluation of the Mini Zoo cum Children's Park, Kalaburagi, Karnataka vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on March 29<sup>th</sup>, 2022.

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 106<sup>th</sup> meeting of the Technical Committee of the Central Zoo Authority held on September 27<sup>th</sup>, 2022. The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the renewal of recognition of Mini Zoo cum Children's Park, Kalaburagi, Karnataka for a period of two years and to regularise the period after August 19<sup>th</sup>, 2021, subject to compliance with observation/ recommendation in the table below and mid-term evaluation. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of 106<sup>th</sup> Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August 19<sup>th</sup>, 2021 and renewed the recognition of Mini Zoo cum Children's Park, Kalaburagi, Karnataka for a period up to December 1<sup>st</sup>, 2024 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

The evaluation of the Mini Zoo and Children Park, Gulbarga, Karnataka was carried out by Mr. Alankar K. Jha on 29.08.2014. 

Sir,

Reference is invited to your letter No. A5/PACP/CR-30/93-94 dated 26.8.1999 seeking renewal of recognition for the Children Park-cum-Mini Zoo, Gulbarga, Karnataka beyond 30.9.1999 under Section 38H of the Wild Life (Protection) Act, 1972.

The zoo was evaluated on 16<sup>th</sup> August, 2005 by Dr. Anupam Srivastav. The evaluation report was placed before the Technical committee Meeting held on 10.1.2006.

On the recommendations of the Committee, it has been decided to grant renewal of recognition to the Children Park-cum-Mini Zoo, Gulbarga, Karnataka as a mini category zoo for a period up to 30.4.2009 subject to following conditions:-

14.	40	To safeguard against uncontrolled growth in the population of prolifically breeding animals like spotted deer, appropriate population control measures should be implemented, like separation of sexes, sterilization and vasectomy etc.

15.	45	Every enclosure in the zoo should bear a sign board displaying the scientific and ecological information regarding the animals exhibited in it.

Visitor facilities		
16.	49	First aid equipments including anti-venom should be readily available in the premises of the zoo.
Development & Planning		
17.	51	The zoo should prepare a long term master plan for its development. A management plan may also be prepared giving details of proposals and activities for development in the next six years. The copies of the plans should be sent to the Central Zoo Authority.

A half yearly report regarding progress made in implementation of the aforesaid conditions should be submitted to the Central Zoo Authority.

Grant of recognition to Children Park-cum-Mini Zoo, Gulbarga, Karnataka as a mini zoo beyond 30.4.2009 would be considered on the basis of compliance of the conditions stated above and general performance of the zoo at that point of time.
