Sir/Madam,

With reference to above, the recognition of the Kamla Nehru Prani Sangrahalaya, Indore, Madhya Pradesh, under Section 38-H of the Wild Life (Protection) Act, 1972, was valid till August 19, 2022. Application for renewal of recognition was received in this office on September 15, 2022. Shri Krishna Kumar Singh, IFS (Retd.) was deputed by this office to evaluate the zoo on November 20-21, 2025. Copy of the Evaluation Report is enclosed herewith for your perusal and needful action.

Evaluation Report of the Kamla Nehru Prani Sangrahalaya, Indore, Madhya Pradesh was placed before the Technical Committee in its 117th Meeting held on January 16, 2026. The Technical Committee, after detailed deliberation, made its recommendation to the Central Zoo Authority. Subsequently, the Central Zoo Authority in its 43rd Meeting held on February 3rd, 2026 has approved recommendation of the Technical Committee.

As per provisions of sub-section (1), (3) and (4) of Section 38-H under the Wild Life (Protection) Act, 1972, the period after August 19, 2022 is regularized and renewed recognition of the Kamla Nehru Prani Sangrahalaya, Indore, Madhya Pradesh as a **Small Zoo** for a period up to **February 3, 2029** subject to compliance with following conditions as per the Recognition of Zoo Rules, 2009 (RZR) and mid-term evaluation of the zoo.

The Kamla Nehru Prani Sangrahalaya, Indore, Madhya Pradesh shall comply with such standards and norms as specified or imposed by or under the provisions of the Wild Life (Protection) Act, 1972 or the rules made thereunder, and the zoo operator shall comply

with the directions and guidelines issued by the Central Zoo Authority from time to time, for the purpose of maintenance and upkeep of the zoo.

The renewal of recognition of the Kamla Nehru Prani Sangrahalaya, Indore, Madhya Pradesh for period beyond February 3, 2029 would be considered on the basis of compliance of the conditions stated above and general performance of the zoo.

The recognition of the Kamla Nehru Prani Sangrahalaya, Indore, Madhya Pradesh shall be revoked by the Central Zoo Authority at any point of time if the Zoo Operator is found not complying with the stipulated conditions.

Sir,

With reference to above, the undersigned is directed to inform that recognition of the Kamla Nehru Prani Sangrahalaya, Indore under Section 38-H of the Wild Life (Protection) Act, 1972, was valid till January 23, 2019. Application dated October 29, 2018 received in this office from the Officer in-charge, Kamla Nehru Prani Sangrahalaya, Municipal Corporation of Indore, for renewal of recognition. Shri B. K. Singh, IFS (Retired), evaluating officer deputed by this office has evaluated the zoo on February 12 and 13, 2020. Copy of the Evaluation Report is enclosed herewith for your perusal and needful action.

2. Evaluation Report of the Kamla Nehru Prani Sangrahalaya, Indore was placed before the Technical Committee in its 96th Meeting held on July 30, 2020. The Technical Committee, after detailed deliberation, made its recommendation to the Central Zoo Authority.

3. This office issued Office Memorandum F.No.7-10/2020-CZA(PART-I) dated August 25, 2020 regarding renewal of recognition of the zoo. Subsequently, the Central Zoo Authority, in its 37th Meeting held on December 7, 2020, in exercise of powers conferred under sub-section (1), (3) and (4) of Section 38-H under the Wild Life (Protection) Act, 1972, approved recommendation of the Technical Committee.

4. The Central Zoo Authority has regularised the period after January 23, 2019 and renewed recognition of the Kamla Nehru Prani Sangrahalaya, Indore as a Small Zoo for a period up to **August 19, 2022** subject to compliance with following conditions as per the Recognition of Zoo Rules, 2009 (RZR) and mid-term evaluation of the zoo.

5. A compliance report to the Central Zoo Authority on implementation of the aforesaid conditions shall be submitted by the zoo within three months of issue of this letter followed by half-yearly report.

6. The renewal of recognition of the Kamla Nehru Prani Sangrahalaya, Indore for period beyond August 19, 2022 as a Small Zoo would be considered based on compliance of the conditions stated above and general performance of the zoo.

7. The recognition of the Kamla Nehru Prani Sangrahalaya, Indore shall be revoked by the Central Zoo Authority at any point of time if the Zoo Operator is found not complying with the stipulated conditions.

Reference is invited to above cited correspondence. It is to inform that the evaluation of the Kamla Nehru Prani Sangrahalay, Indore was carried out by Dr. Brij Kishor Gupta, Evaluation and Monitoring Officer, CZA and Dr. A. K. Sharma, Sr. Scientist of Indian Veterinary Research Institute, Bareilly on 20th December, 2016. The evaluation report of the Kamla Nehru Prani Sangrahalay, Indore, as submitted by the evaluating officer was considered by the Technical Committee in its 81st Meeting held on 24th January, 2017.

The Technical Committee of the Central Zoo Authority has decided to grant conditional renewal of recognition for a period of two years. The renewal of recognition of Kamla Nehru Prani Sangrahalay, Indore as "small category zoo" under provisions of Section 38H of the Wild Life (Protection) Act, 1972 is for a period up to 23rd January, 2019 subject to the compliance of the following directives under the Recognition of Zoo Rules, 2009 and mid-term evaluation of the Kamla Nehru Prani Sangrahalay, Indore:

OTHER RECOMMENDATIONS-


- (i) Buffer of trees should be created around the veterinary hospital. The area should then be fenced with chain link fence with only one entry gate.
- (ii) Removable wooden plank flooring should be provided in the feeding cells of all the carnivores.
- (iii) Keeper galleries of all the carnivore enclosures should have provision of almirah, table and chair to facilitate the keepers to work efficiently.
- (iv) All keepers should be provided overalls/working uniform and should not be allowed to work in the zoo without being in proper uniform.

A half yearly report regarding progress made in implementation of the aforesaid conditions should be submitted to the Central Zoo Authority.

Grant of recognition to Kamla Nehru Prani Sangrahalaya, Indore beyond 31st August 2016 as "a Small Category Zoo" would be considered on the basis of compliance of the conditions stated above and general performance of the zoo. Submission of Master Plan be expedited.

The recognition to the Kamla Nehru Prani Sangrahalaya, Indore shall be revoked by the Central Zoo Authority, at any point of time if the Zoo Operator is found not complying with the stipulated conditions.

Reference is invited to your office letter No. 969 dated 31.03.2009 seeking grant of renewal of recognition to the Kamla Nehru Prani Sangrahalaya, Indore beyond the period of 31.09.2008 under Section 38H of the Wild Life (Protection) Act, 1972.

The evaluation of the Kamla Nehru Prani Sangrahalaya, Indore was carried out on 12th March, 2009 by Dr. B. R. Sharma, Member Secretary, CZA. The evaluation report submitted by the evaluating officer was considered by the Technical Committee in its 51st Meeting held on 23rd July, 2009.

The Central Zoo Authority has decided to grant renewal of recognition to the Kamla Nehru Prani Sangrahalaya, Indore as a small category Zoo under Section 38H of the Wild Life (Protection) Act, for a period up to 30th September, 2012 subject to the compliance of the following directives under the Recognition of Zoo Rules, 1992:-

Grant of recognition beyond 30th September, 2012 to the Kamla Nehru Prani Sangrahalaya, Indore as a 'Small category zoo' would be considered on the basis of compliance of the above conditions, general performance and physical evaluation of the zoo.

The recognition to the Kamla Nehru Prani Sangrahalaya, Indore shall be revoked by the Central Zoo Authority, at any point of time if the Zoo Operator is found not complying with the stipulated conditions.
