Sir/Madam,

With reference to above, I am directed to inform that the recognition of Amte's Animal Ark (Orphanage cum Rescue Center), Hamelkasa, Maharashtra was accorded up to August 19<sup>th</sup>, 2021 vide reference no. 3 above. The application for the renewal of recognition of Amte's Animal Ark (Orphanage cum Rescue Center), Hamelkasa, Maharashtra for the period beyond August 19<sup>th</sup>, 2021 was received by this office vide reference no. 2 above.

Dr. Rajeev Mishra, IFS (Retd.) was deputed by this office to carry out the evaluation of the Amte's Animal Ark (Orphanage cum Rescue Center), Hamelkasa, Maharashtra vide CZA letter at reference no. 1 above. The Zoo was accordingly evaluated on June 21<sup>st</sup>, 2022.

The evaluation report (copy enclosed) as submitted by the evaluation officer was deliberated in the 106<sup>th</sup> meeting of the Technical Committee of the Central Zoo Authority held on September 27<sup>th</sup>, 2022. The Technical Committee after detailed deliberations recommended to the Central Zoo Authority for the renewal of recognition of Amte's Animal Ark (Orphanage cum Rescue Center), Hamelkasa, Maharashtra for a period of two years and to regularise the period after August 19<sup>th</sup>, 2021, subject to compliance with observation/ recommendation in the table below and mid-term evaluation. The members also recommended that the Zoo Operator may be directed to submit half-yearly compliance report with respect to observation/ recommendation stipulated while renewal of recognition.

Subsequently, the recommendation of 106<sup>th</sup> Technical Committee Meeting was approved by the Chairperson, Central Zoo Authority. Accordingly, the Central Zoo Authority has regularised the period after August 19<sup>th</sup>, 2021 and renewed the recognition of Amte's Animal Ark (Orphanage cum Rescue Center), Hamelkasa, Maharashtra for a period up to December 5, 2024 under Section 38-H(1), (3) & (4) of the Wild Life (Protection) Act, 1972. This is subject to the ratification of this decision in the next meeting of the Central Zoo Authority.

The recognition of Amte's Animal Ark (Orphanage cum Rescue Center), Hemalkasa, Maharashtra shall be revoked by the Central Zoo Authority, at any point of time, if the zoo operator is found not complying with the stipulated conditions.

Sir,

With reference to above, the undersigned is directed to inform that recognition of the Amte's Animal Ark, Hemalkasa, under Section 38-H of the Wild Life (Protection) Act, 1972, was valid till November 3, 2017. Application dated October 10, 2017 received in this office from the Director, Amte's Animal Ark, Hemalkasa, for renewal of recognition. Shri D.N.S. Suman, IFS (Retired), evaluating officer/s deputed by this office has evaluated the zoo on February 8, 2020. Copy of the Evaluation Report is enclosed herewith for your perusal and needful action.

2. Evaluation Report of the Amte's Animal Ark, Hemalkasa was placed before the Technical Committee in its 96<sup>th</sup> Meeting held on July 30, 2020. The Technical Committee, after detailed deliberation, made its recommendation to the Central Zoo Authority.

3. This office issued Office Memorandum F.No.7-10/2020-CZA(PART-I) dated August 25, 2020 regarding renewal of recognition of the zoo. Subsequently, the Central Zoo Authority, in its 37<sup>th</sup> Meeting held on December 7, 2020, in exercise of powers conferred under sub-section (1), (3) and (4) of Section 38-H under the Wild Life (Protection) Act, 1972, approved recommendation of the Technical Committee.

4. The Central Zoo Authority has regularised the period after November 3, 2017 and renewed recognition of the Amte's Animal Ark, Hemalkasa as a Rescue Centre for a period up to **August 19, 2021** subject to compliance with following conditions as per the Recognition of Zoo Rules, 2009 (RZR) and mid-term evaluation of the zoo.



Reference is invited to above cited correspondence. It is to inform that the evaluation of Amte's Animal Ark Rescue Centre, Hemalkasa, District Gadchiroli was carried out by Dr. Brij Kishor Gupta, Evaluation and Monitoring Officer, CZA on 28<sup>th</sup> September, 2016. The evaluation report of the Amte's Animal Ark Rescue Centre as submitted by the evaluating officer was considered by the Technical Committee in its 80<sup>th</sup> Meeting held on 4<sup>th</sup> November, 2016.

The Technical Committee of the Central Zoo Authority has decided to grant conditional renewal of recognition for a period of one year. Also, the Committee decided to issue Show Cause Notice to operator of the Rescue Centre and to provide time to comply with observations made by the Central Zoo Authority. Show Cause Notice is being sent separately. The renewal of recognition of Amte's Animal Ark Rescue Centre as a "Rescue Centre" as per the provisions of Section 38H of the Wild Life (Protection) Act, 1972 is for a period up to 3<sup>rd</sup> November, 2017 subject to the compliance of the following directives under the Recognition of Zoo Rules, 2009 and mid-term evaluation of the zoo:-

The recognition to the Amte's Animal Ark, Hemalkasa, District Gadchiroli shall be revoked by the Central Zoo Authority, at any point of time if the Zoo Operator is found not complying with the stipulated conditions.
